Saint John Neumann Regional School

What is your scheduled first day of school for the 2020-2021 school year? Aug 31, 2020

How do you plan to bring students and staff back to physical school buildings, particularly if you still need social distancing in place?

As long as Carbon and Lehigh counties are operating in the GREEN or YELLOW phase of operations, we intend to provide in-person instruction after developing a written Health and Safety Plan to be approved by the Diocese of Allentown. We will also offer virtual instruction, to be completed from home, that would also provide a continuum of learning for the families who are not comfortable returning to school just yet. St. John Neumann Regional School plans to maintain communications with local and state Dept. of Public Health officials for guidance as needed. Signage will be posted in classrooms, hallways, restrooms, and entrances to communicate the importance of how to stop the spread of Covid19. Preventative measures will be stressed along with good hygiene practices and specific protocols. Protocols for students and staff who feel ill or experience symptoms will be established and we are considering ways to accommodate the needs of our high-risk population. All classrooms, common areas, stairwells, offices, and meeting areas will be sanitized and disinfected properly using EPA approved cleaning solutions. Social distancing spaces will be marked on tables, floors, and walls as dictated by the current guidelines.

How did you engage stakeholders in the type of re-opening your school entity selected?

In order to develop our plan for re-opening St. John Neumann Regional School, several school families were asked to participate in a ZOOM meeting and offer their insights and opinions on how safe they feel returning to school in August, and what we, as a school community, could do to calm and address their concerns. The group was composed of the principal, three faculty representatives, a medical doctor, two nurses, several parents, and three students. After the initial meeting, the teachers and administrative staff met to address concerns and brainstorm possible scenarios and solutions. Both groups met at least twice to brainstorm and offer input on the back to school protocols.

How will you communicate your plan to your community?

SJNRS will communicate our plan to the community by emailing it to our school families, staff, pastors, advisory board members, and other stakeholders who have an interest in our school. The plan will also be posted to our school website and social media.

Once you reopen, what will the decision-making process look like to prompt a school closure or other significant modification to operations?

Once SJNRS reopens in the Fall, we will follow the directives of the Diocese of Allentown, the PA Governor's orders, the PA Department of Health, and the Center for Disease Control recommendations. Both local health officials and Office of Education will be notified. The school will receive consultation and guidance from the Department of Health and interaction and direction with the Diocesan Office of Education. Should we need to make a significant modification to our operations, the guidance will be emailed, posted on our school website and social media page, as well as broadcast on the following Television stations:

How will you ensure the building is cleaned and ready to safely welcome staff and students?

Cleaning, sanitizing, and disinfecting will be performed in accordance with current CDC and PA DOH guidelines. EPA approved products will be used in accordance with labeling requirements. Each teacher will be in charge of disinfecting his or her own classroom at several times throughout the day. The custodial staff will focus on everyday responsibilities and stress excessively touched items, restrooms, railings. etc. Any dirty surfaces will be washed with soap and water or cleaner before disinfecting.

How will you procure adequate disinfection supplies meeting OSHA and CDC requirements for COVID-19?

Cleaning, sanitizing, and disinfecting will be performed in accordance with current CDC and PA DOH guidelines. EPA approved products will be used in accordance with labeling requirements and staff will be trained on how to appropriately use these products.

EPA Disinfectants: EPA #47371-129 and EPA# 82972-1

SJNRS orders sanitizing and disinfectants through two vendors, Lehigh Valley Janitorial and Office Basics. If cleaning solutions need to be mixed with water, one person will do all of the mixing and distribution to classrooms and staff in order to keep uniformity.

How often will you implement cleaning, sanitation, disinfecting, and ventilation protocols/procedures to maintain staff and student safety?

The cleaning, sanitizing, disinfecting, and ventilation of a school community are an important part of reducing the risk of Covid19. Normal, routine cleaning with soap and water alone can reduce the risk of exposure and is a necessary step before distinfecting surfaces can take place. As a school community, SJNRS will require each teacher and staff member to be responsible for cleaning his/her own area. This will include wiping down desks, chairs, countertops, keyboards, etc. upon arrival, between classes, at lunch time, and at dismissal. Teachers and staff will be required to use hand sanitizer or wash hands with soap and water at hourly intervals, including before and after leaving the classroom or shared area.

What protocols will you put in place to clean and disinfect throughout an individual school day?

There will be several protocols put in to place to clean and disinfect properly during the school day. Cleaning, sanitizing, and disinfecting will be performed in accordance with the current CDC and PA DOH guidelines. EPA approved products will be utilized and staff will be trained on how to appropriately use these products. If products are in short supply, a mixture of one -third cup bleach to one gallon of water will be utilized in a spray bottle. Custodial staff will be instructed to clean excessively touched items through out the school day, such as doors, railings, light switches, printers, copiers, etc. Water fountains will be used ONLY to refill water bottles from home. Restrooms and toilets will be maintained using the proper PPE equipment to disinfect toilets, urinals, sinks, paper towel dispensers, and partitions. Floors will be cleaned daily by first dry mopping, then wet mop with a disinfectant. Staff will don proper PPE equipment (masks or face shields, gloves, safety glasses) to clean classrooms and common areas of school building. Hand soap and hand sanitizer stations will be provided in high traffic areas, as well as individual classrooms and offices. Signs will be posted at entrances, bathrooms, and throughout the school to reduce the risk of spreading Covid-19 virus.

Which stakeholders will be trained on cleaning, sanitizing, disinfecting, and ventilation protocols? When and how will the training be provided? How will preparedness to implement as a result of the training be measured?

The faculty and staff, including lunch person and cleaner, will be trained on proper methods of cleaning, sanitizing, and disinfecting. The staff and students of SJNRS will be expected to adhere to hygiene practices set forth by the CDC and PA DOH including the manner and frequency of hand washing and other best practices. The custodial staff will be

shown the new ventilation system so that an increase of outside air will be introduced to the building through the current HVAC system. Air filter changes will remain on the same schedule and windows will be opened in areas where the

HVAC system is not capable of outside air transfer. The training will be provided by the vendor who supplies our cleaning products in the month of August. If scheduling conflicts do not allow for face to face training, a ZOOM meeting or webinar may be utilized. Preparedness to implement as a result of training will be measured by each staff member demonstrating the correct methods of cleansing, sanitizing, and disinfecting in the school environment or by signing and dating a statement that a webinar training was viewed.

How will classrooms/learning spaces be organized to mitigate spread?

Classroom/ learning space occupancy of 3-6 feet of separation of student desks and tables will be allowable with our student enrollment. Kindergarten tables will be marked with plexiglass divider to separate table into fourths. Grades 1-8 will be able to socially distance desks and seating spaces. Plastic desk top dividers have been ordered for the grades that seek a more structured division of personal space. For those students or families who are not comfortable physically returning to school on August 31, 2020, SJNRS will offer a Virtual Academy of instruction to mirror the classroom teaching and learning that can be accessed remotely from home. The families who opt for this remote learning will decrease the number in students in the classrooms and free space to be configured into the social distancing guidelines.

How will you group students with staff to limit the number of individuals who come into contact with each other throughout the school day?

In order to decrease the number of students and staff who come into contact with each other throughout the school day,

the following options will be employed: Students in grades K-2 will be sent directly to classroom instead of gathering in

hallway (after temperatures are taken and recorded). Grades 3-8 can gather in school cafeteria, wearing masks and sitting in socially distanced seat. Students may not leave seat until after morning announcements and temperature check before entering building. In grade 6-8, teachers will switch classroom for subjects requiring different teacher. Students will remain in homeroom. Recess and lunch times will be adjusted to allow for least amount of people gathered in cafeteria in grades 3-8. Grades K-2 will eat lunch in classrooms. Recess times will be staggered to allow for proper social distancing. Students will be called and dismissed according to bus arrivals, instead of large gathering in school hall.

What policies and procedures will govern use of other communal spaces within the school building?

Hand sanitizer for students and staff will be made available. Disposable plates, utensils, napkins, etc. will be used with lunch preparation and service. Spaced lines will be marked to enter and exit the cafeteria and stairwells, staggered use of common areas, and wearing of masks while in school. Cafeteria tables will be sanitized before and after students use tables and chairs. Areas of common areas and hallways will be designated to promote one way flow of movement.

How will you utilize outdoor space to help meet social distancing needs?

We will stagger outdoor recess times by class to meet social distancing guidelines. Classes will not be permitted to mix with other grades as usual for recess. Hula hoops can be utilized to mark 3-6 feet increments.

How will you adjust student transportation to meet social distancing requirements?

Sympton screening will be done by parents or guardians at home each morning before the school day. No children with symptons will be sent on a bus or brought to school. Buses can operate with a maximum of two students per seat, with the understanding that masks will be required of students while on the bus and upon entrance into school buildings. The enrollment numbers of SJNRS allow for social distancing on all busses. No food or drink will be allowed on bus. Field trips will be discontinued in lieu of virtual experiences.

What visitor and volunteer policies will you implement to mitigate spread?

Visitors will be permitted on an as-needed basis, and must call office before arrival. Temperature of visitor will be taken as well as completion of Covid-19 Screening Checklist for visitors and staff questionnaire. Signs will be posted in hallways and entrances to illustrate how to stop the spread of covid-19 virus. Hand sanitizer will be provided to all staff, students, and visitors upon entering the building.

Will any of these social distancing and other safety protocols differ based on age and/or grade ranges?

The only safety protocols that will differ based on age or grade levels is for our Kindergarten class. SJNRS will purchase clear plexiglass table dividers that will allow for social distancing and a physical barrier between the chidren. These clear dividers will allow for children to view the teacher's mouth especially when learning and imitating sounds and formation of words. In the event these dividers cannot be acquired before the opening of school, students will have to wear masks.

Which stakeholders will be trained on social distancing and other safety protocols? When and how will the training be provided? How will preparedness to implement as a result of the training be measured?

The stakeholders that will be trained on social distancing and other safety procols will include the administration, faculty, staff, and students of SJNRS. The training will either be provided by the vendor who provides our sanitizers and disinfecting materials or a Safe School webinar training video to be viewed by school community. Signage throughout the school campuses will also provide guidelines on social distancing and other necessary safety protocols. Preparedness to implement as a result of the training will be a sign off sheet for adults and staff who have viewed the mandatory training video.

How will you monitor students, staff, and others who interact with each other to ensure they are healthy and not exhibiting signs of illness?

Students, staff, and others who interact with each other will be monitored by temperature checks upon arrival. If fever is present, student will be seperated from others and parents will be called to pick up student. Adults and staff and visitors will complete screening questions upon arrival as well.

Where, to whom, when, and how frequently will the monitoring take place (e.g. parent or child report from home or upon arrival to school)?

It is assumed that parents will take child's temperature at home before leaving from school and will keep child home if a fever or other Covid symptoms are present. Students, as well as adults and visitors, will have temperatuer checks upon arrival to SJNRS.

What is the policy for quarantine or isolation if a staff, student, or other member of the school community becomes ill or has been exposed to an individual confirmed positive for COVID-19?

The person will be moved to an isolated area of our stage in Palmerton Campus and the outer office area in Slatington Campus.

Quarantine is used to keep someone who might have been exposed to COVID-19 away from others. Quarantine helps prevent spread of disease that can occur before a person knows they are sick or if they are infected with the virus without feeling symptoms. People in quarantine should stay home, separate themselves from others, monitor their health, and follow directions from their state or local health department.

Which staff will be responsible for making decisions regarding quarantine or isolation requirements of staff or students?

The principal, in consulatation with the PA DOH and the Office of Education of the Diocese of Allentown, will be responsible for making decisions regarding quarantine or isolation requirements of SJNRS staff or students.

What conditions will a staff or student confirmed to have COVID-19 need to meet to safely return to school? How will you accommodate staff who are unable to uncomfortable to return?

Anyone who has been in close contact with someone who has COVID-19.

This includes people who previously had COVID-19 and people who have taken a serologic (antibody) test and have antibodies to the virus.

What counts as close contact?

You were within 6 feet of someone who has COVID-19 for at least 15 minutes

You provided care at home to someone who is sick with COVID-19

You had direct physical contact with the person (touched, hugged, or kissed them)

You shared eating or drinking utensils

They sneezed, coughed, or somehow got respiratory droplets on you

Steps to take

Stay home and monitor your health

Stay home for 14 days after your last contact with a person who has COVID-19 Watch for fever (100.4°F), cough, shortness of breath, or other symptoms of COVID-19 If possible, stay away others, especially people who are at higher risk for getting very sick from COVID-19 When to start and end guarantine

You should stay home for 14 days after your last contact with a person who has COVID-19.

Staff who are unable or uncomfortable to return to school will be offered the possibilty of working remotely from home, if possible.

How will you determine which students are willing/able to return? How will you accommodate students who are unable or uncomfortable to return?

Date of last close contact with person who has COVID-19 + 14 days= end of quarantine You can be with others after

3 days with no fever and Respiratory symptoms have improved (e.g. cough, shortness of breath) and 10 days since symptoms first appeared temperature high light icon

Depending on your healthcare provider's advice and availability of testing, you might get tested to see if you still have COVID-19. If you will be tested, you can be around others when you have no fever, respiratory symptoms have improved, and you receive two negative test results in a row, at least 24 hours apart.

In order to accommodate students who are unable or uncomfortable to return to school, a virtual component of classwork will be made available.

When and how will families be notified of confirmed staff or student illness or exposure and resulting changes to the local Health and Safety Plan?

Generally, contact tracing includes the following steps:

Case investigation: Public health staff work with a patient to help them recall everyone they have had close contact with during the time they may have been infectious.

Contact tracing: Public health staff begin contact tracing by notifying exposed people (contacts) of their potential exposure as rapidly and sensitively as possible, not revealing the infected patient's identity.

Contact support: Contacts are provided with education, information, and support to help them understand their risk, what they should do to separate themselves from others who are not exposed, and how to monitor themselves for illness. In addition, they are informed of the possibility that they could spread the infection to others even if they do not feel ill.

Self-quarantine: Contacts are encouraged to stay home, monitor their health, and maintain social distance (at least 6 feet) from others until 14 days after their last exposure to the infected patient, in case they also become ill.

Which stakeholders will be trained on protocols for monitoring student and staff health? When and how will the training be provided? How will preparedness to implement as a result of the training be measured?

The administration, faculty, staff, students, parents and volunteers of SJNRS will be trained on protocols for monitoring student and staff health. The training will be provided in person through a local health care agency, if possible. If not feasible in person, a Safe Schools professional development webinar will be viewed. Preparedness to implement as a result of training will be a sign≡oo sheet signed by participant.

What is the local policy/procedure regarding face coverings for staff? What is the policy/procedure for students? On July 1, 2020, the Secretary of the Pennsylvania Department of Health announced an Order Requiring Universal Face Coverings. The order, signed under Secretary Levine's authority under the Disease Prevention and Control Act, outlines the situations when a mask must be worn and includes limited exceptions to the face-covering requirement.

The Order requires individuals, including students and teachers, to wear a "face covering." "Face covering" means a covering of the nose and mouth that is secured to the head with ties, straps, or loops over the ears or is wrapped around the lower face. A "face covering" can be made of a variety of synthetic or natural fabrics, including cotton, silk, or linen, and, for the purposes of the order, can include a plastic face shield that covers the nose and mouth. "Face coverings" may be factory-made, sewn by hand, or improvised from household items, including but not limited to, scarves, bandanas, t-shirts, sweatshirts, or towels. While procedural and surgical masks intended for health care providers and first responders, such as N95 respirators, would meet these requirements, these specialized masks should be reserved for appropriate occupational and health care settings.

Under what circumstances are students permitted to remove their face coverings (e.g. masks and face shields)?

Schools may allow students to remove their face coverings when students are:

- 1. Eating or drinking when spaced at least 6 feet apart;
- 2. Seated at desks or assigned work spaces at least 6 feet apart; or
- 3. Engaged in any activity at least 6 feet apart (e.g. face covering breaks, recess, etc.).

What special protocols will you implement to protect students and staff at higher risk for severe illness?

It is especially important for people at increased risk of severe illness from COVID-19, and those who live with them, to protect themselves from getting COVID-19.

The best way to protect yourself and to help reduce the spread of the virus that causes COVID-19 is to:

Limit your interactions with other people as much as possible.

Take precautions to prevent getting COVID-19 when you do interact with others.

If you start feeling sick and think you may have COVID-19, get in touch with your healthcare provider within 24 hours.

We will also live stream our classroom teachers, as well as special teachers, who will employ a tripod and phone to Zoom those students who are not comfortable returning in person at this time. Facilities Cleaning, Sanitizing, Disinfecting and Ventilation

Strategies, Policies & Procedures

Cleaning, sanitizing, disinfecting, and ventilating earning spaces, surfaces, and any other areas used by students (i.e., restrooms, drinking fountains, hallways, and transportation)

Hygiene practices for students and staff including the manner and frequencyof hand washing: staff and students are expected to adhere to hygiene practices set forth by CDC and PA DOH. PPE willbe utilized by staff and students in accordance with guidelines. Hand soap or sanitizer will be provided with at least 60% alcohol, paper towels in all bathrooms, classrooms, and high-traffic areas. Posting signs in highly visible locations, that promote everyday protective measures, and how to stop the spread of germs. Items should not be shared between students to reduce the spread of infectious bodily fluids. Items that may need to be shared should be disinfected in accordance with CDC and PA DOH guidelines after use. Allow students to and staff to bring water bottles from home.

Social Distancing and Other Safety Protocols

Strategies, Policies & Procedures

Classroom/learning space occupancy that allows for 3-6 feet of separation among students and staff throughout the day, to the maximum extent feasible

Elementary students will have have desks and /or tables set to allow for a minimum 0f 3-6 feet of distance from their peers and staff. Utilizing outdoor space as often as possible will be key in preventing the spread of infection.

Strategies, Policies & Procedures

Restricting the use of cafeterias and other congregate settings, and serving meals in alternate settings such as classrooms

If SJNRS is operating in the yellow phase, meals will be served in the classrooms for grades K-2. Grades 3-8 pick up disposable trays of lunch items or packed lunch froom home and follow spaces marked on floor to designate social distancing. Students remain in assigned seats. Absolutely no sharing of food, drinks, or utensils will be permitted. Cleaning of cafeteria and other high-touch surfaces will be performed beofre and after lunch. Adjusting transportation schedules and practices to create social distance between students Symptom screening will be done by all parents and guardians at home each moring before the school day. No children with symptoms will be sent on a bus or to school. Buses can operate witha maximum of two students per seat. Masks will be required of all students and driver and staff on bus. Bus company will establish protocalls for bus stops, loading and unloading students to minimize congregation of children from different households. Spaced seating will be implemented to ensure social distancing between all passengers. Visual cues will be affixed to bus areas where students should not sit. HAnd sanitizer will be provided for students, driver, and monitor. Face masks will be worn on bus. No field trips, food or drink allowed on bus. Frequently touched surfaces will be cleaned and disinfected after each scheduled run. Air our buses when not in use.
